

# MEMORANDUM OF UNDERSTANDING between KASETSART UNIVERSITY and YOGYAKARTA STATE UNIVERSITY



#### **General Cooperation in Education and Research Activities**

Kasetsart University and Yogyakarta State University hereby enter into this **Memorandum of Understanding (**hereinafter called MoU) to foster international cooperation in education and research.

### ARTICLE 1 Purpose and Objective

Under this MoU, both Kasetsart University and Yogyakarta State University agree to work and strengthen academic cooperation as "SISTER UNIVERSITY" with a privilege pertinent.

#### ARTICLE 2 Scope of Cooperation

- 1. Both parties agree to encourage the following activities in particular to promote international academic cooperation.
  - a) Exchange of faculty members and research scholars;
  - b) Exchange of students;
  - c) Joint research activities and meetings for education and research;
  - d) Exchange of materials in education and research, publications and academic information;
  - e) Other activities as agreed upon by both parties.
- 2. Before these activities can be implemented, both parties shall discuss the problems involved to the satisfaction of each party and enter into specific Activity Agreements based on the forms of implementation mutually agreed upon.
- 3. This Memorandum of Understanding shall be applicable to educational and research organizations attached to each party.

#### ARTICLE 3 Duration

- 1. This Memorandum of Understanding shall become effective as of the date of signature by the presidents of both parties. The amendment or the termination of this General Agreement shall not be effected without deliberation between the two parties.
- 2. Both parties agree that this Memorandum of Understanding should be reviewed every five (5) years in order to evaluate progress and improve the quality of the exchange.



#### ARTICLE 4 Notices

- 1. Each party shall designate an office to serve as liaison person for this Memorandum of Understanding. For Yogyakarta State University this office will be Office of International Affairs and Partnerships, and for Kasetsart University it will be International Affairs Division, Office of the President.
- 2. Authorized representatives of Kasetsart University and Yogyakarta State University shall sign two original MoU documents, both documents being equally authentic.
